

Contest Rules: WGL ENERGY SERVICES, INC. (WGL Energy) — NATIONALS BULLPEN CART RIDE

1. ELIGIBILITY:

(a) No purchase necessary. Void where prohibited.

(b) To be eligible for this contest, you must: (i) be a legal resident of the state of Maryland, Virginia, Delaware, Pennsylvania or the District of Columbia of the age of majority and (ii) be living within the utility service area of Washington Gas Virginia, Columbia Gas Virginia, Baltimore Gas and Electric, Pepco MD or DC, Potomac Edison MD, Delmarva Power MD or DE, PPL Electric Utilities or PECO and (iii) have a valid Maryland, Delaware, Pennsylvania, Virginia or District of Columbia home address.
